Opening statement

Aims to eradicate discrimination

We believe that a greater level of success from pupils and staff can be achieved by realising the uniqueness of individuals, in line with our 'We are unique' value. Creating an inclusive environment where individuals feel confident and at ease is a commitment of the school. This environment will be achieved by:

- Being respectful.
- Always treating all members of the school community fairly.
- Developing an understanding of diversity and inclusion and the benefits it can have.
- Adopting an inclusive attitude and ensuring that the whole school community understands what inclusive behaviour looks like in the school and how this aligns with the school's values.
- Adopting an inclusive curriculum that is accessible to all.
- Encouraging compassion and open-mindedness.
- Challenging bias and calling it out in order to move the conversation forward.

We aim to limit and abolish prejudicial incidents by ensuring all children are taught about the importance or diversity and inclusion through our RSHE curriculum and assembly plan. We are

committed to having a balanced, diverse and fair curriculum. We believe that our pupils should be exposed to ideas and concepts that may challenge their understanding, to help ensure that pupils learn to become more accepting and inclusive of others. Challenging and controversial concepts will be delivered in a way that prevents discrimination and promotes inclusive attitudes.

Incidents of discrimination will be recorded on our 'My Concern' safeguarding system, broken down by different characteristics e.g. race, gender. Data from these incidents will be analysed on a termly basis in the Headteacher's report to governors in order to identify patterns and opportunities for learning and training needs.

Dealing with prejudice and celebrating diversity

We do not tolerate any form of prejudice-related incident. Whether direct or indirect, we treat discrimination against all members of our school with the utmost severity. When an incident is reported, our school is devoted to ensuring appropriate action is taken and a resolution is put into place which is both fair and firm.

Our pupils are taught to be:

- Understanding of others.
- Celebratory of diversity.
- Eager to reach their full potential.
- Inclusive and understanding of the needs of different children and how the curriculum and behaviour policy need to be adapted to meet their needs.
- Aware of what constitutes discriminatory behaviour.

The school's employees will not:

The school's employees will:

- Encourage and adopt an inclusive attitude.

- Seek training if they need to improve their knowledge in a particular area.

- Planning assemblies to promote key diversity awareness days, celebrations and a range of people from diverse backgrounds.
- Inviting guest speakers to talk to pupils about diversity.
- Incorporating lessons about diversity into the curriculum.
- Reading books from a diverse range of authors through our reading and writing curriculum.
